7 **A Resolution confirming an award by the Board of Control of a construction contract with**  
8 **Perrin Asphalt Company for the 2020 Summit County Concrete Pavement Repair**  
9 **Program, in an amount not to exceed \$345,907.00, for the Engineer, and declaring an**  
10 **emergency.**

11  
12 WHEREAS, this Council previously adopted Resolution No. 2019-452, which authorized  
13 the County Executive to advertise as needed for bridge engineering and construction projects,  
14 and pavement maintenance projects, for the Engineer's 2020 Capital Improvements Program,  
15 for an estimated total cost not to exceed \$5,290,750.00; and

16  
17 WHEREAS, following the receipt and review of bids, the County Executive proposes  
18 entering into a construction contract with Perrin Asphalt Company for the 2020 Summit County  
19 Concrete Pavement Repair Program, in an amount not to exceed \$345,907.00; and

21 WHEREAS, the Board of Control, at its meeting held April 8, 2020, awarded a  
22 construction with Perrin Asphalt Company for the 2020 Summit County Concrete Pavement  
23 Repair Program, in an amount not to exceed \$345,907.00, subject to confirmation by County  
24 Council; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that aforementioned construction contract with Perrin Asphalt Company is necessary and in the  
28 best interest of the County of Summit.;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that;

35 The award by the Board of Control of a construction contract with Perrin Asphalt  
36 Company for the 2020 Summit County Concrete Pavement Repair Program, in an amount not to  
37 exceed \$345,907.00, is hereby confirmed and the County Executive is hereby authorized to  
38 execute such construction contract and any other necessary related documents.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the residents of the County of Summit, and for the further purpose to immediately  
44 provide a necessary construction contract for the 2020 Summit County Concrete Pavement  
45 Repair Program.
