7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award by the Public Utilities Commission of Ohio of a 2015 training fund grant,**  
9 **for the period 2/3/15 through 8/3/16, in the amount of \$33,200.00, with no local cash match**  
10 **requirement, and appropriating funds, for the Executive Department of Law, Insurance**  
11 **and Risk Management - Division of Public Safety/ Emergency Management Agency, and**  
12 **declaring an emergency.**

14 WHEREAS, the Public Utilities Commission of Ohio ("PUCO") has awarded a PUCO  
15 training fund grant to the Summit County Emergency Management Agency ("SCEMA"), for the  
16 period 2/3/15 through 8/3/16, in the amount of \$33,200.00, with no local cash match  
17 requirement, to provide for SCEMA Special Operations Response Team ("SORT") trainings;  
18 and

20 WHEREAS, the trainings will be provided to fire service personnel for Hazmat IQ, Rad  
21 IQ and Hazmat IQ Tox-Medic; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
25 execute any documents necessary to accept the award of the aforementioned grant from the  
26 PUCO, and to appropriate these grant funds;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

33 The County Executive is hereby authorized to execute any documents necessary to accept  
34 the award of a Public Utilities Commission of Ohio ("PUCO") training fund grant award from  
35 the PUCO, for the period 2/3/15 through 8/3/16, in the amount of \$33,200.00, with no local cash  
36 match requirement.
