WHEREAS, after closing a wing of the Summit County Jail, the Sheriff has begun sending inmates to jails in surrounding counties and municipalities, such as Stark County, Geauga County and North Royalton; and				
WHEREAS, sometimes transferred inmates require medical attention outside of the jail where they were sent, thus incurring medical costs at facilities that were selected solely by the jail nousing those inmates; and				
WHEREAS, Section 177.07(a)(2) of the Codified Ordinances of the County of Summit xempt from competitive bidding contracts with other governmental entities, including those that could contract with the County to house inmates in their jails; and				
WHEREAS, Section 177.07(a)(5) of the Codified Ordinances of the County of Summi exempts from competitive bidding contracts with suppliers of goods and services that are sole source entities, meaning that they are the only vendor that is able to provide a good or service, including those medical providers that are selected solely by the governmental entities that operate jails where the County's inmates may be held; and
