7 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**
8 **with the Development Finance Authority of Summit County whereby the County**
9 **Executive's Office will provide prevailing wage coordination for the Reminderville**
10 **Recreation Center Project, for the Executive, and declaring an emergency.**

12 WHEREAS, the Development Finance Authority of Summit County ("DFA") is a port
13 authority under Chapter 4582 of the Ohio Revised Code; and

14
15 WHEREAS, the DFA is issuing bonds for the construction of the Reminderville
16 Recreation Center Project in the Village of Reminderville (the "Project"); and

17
18 WHEREAS, the DFA has the obligation of serving as the prevailing wage coordinator for
19 the Project; and

20
21 WHEREAS, due to recent changes in staff, the DFA desires to contract with the County
22 to perform the prevailing wage coordination services for the Project and to further train new
23 DFA staff to perform the same; and

25 WHEREAS, the County Executive desires to enter into an intergovernmental agreement
26 with the DFA to provide prevailing wage coordination services for the Project for the sum of
27 \$400.00 per month until the Project is completed; and

29 WHEREAS, Section 9.482 of the General Provisions of the Ohio Revised Code permit
30 the County and DFA to enter into the aforementioned agreement; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that it is necessary and in the best interest of the County to authorize the County Executive to
34 execute the aforementioned agreement.

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

39 SECTION 1

41 The County Executive is hereby authorized to execute an intergovernmental agreement
42 with the DFA whereby the County Executive's Office will provide prevailing wage coordination
43 services for the Project in exchange for the sum of \$400.00 per month until the Project is
44 complete.

46 SECTION 2

48 This Resolution is hereby declared an emergency in the interest of the health, safety and
49 welfare of the citizens of the County of Summit, and for the further reason to immediately
50 authorize the execution of the aforementioned agreement so as to not provide any undue delay in
51 the construction of the Project.
