13 WHEREAS, the County of Summit Veterans Service Commission requests that the
14 County Executive be authorized to advertise for bids for armed security guard services at the
15 County of Summit Veterans Service Commission Building, 1060 East Waterloo Road, Akron,
16 Ohio 44306, in Council District 8, for a one-year term, with four options to renew for an
17 additional one-year term, for an estimated first year amount not to exceed \$26,908.00; and

19 WHEREAS, a copy of the bid specifications are attached to this Resolution as Exhibit A;

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
24 advertise for bids for armed security guard services at the County of Summit Veterans Service
25 Commission Building, for a one-year term, with four options to renew for an additional one-year
26 term, for an estimated first year amount not to exceed \$26,908.00;

33 The County Executive is hereby authorized to advertise for bids for armed security guard
34 services at the County of Summit Veterans Service Commission Building, 1060 East Waterloo
35 Road, Akron, Ohio 44306, in Council District 8, for a one-year term, with four options to renew
36 for an additional one-year term, for an estimated first year amount not to exceed \$26,908.00.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the citizens of the County of Summit and for the further reason that it is immediately
42 necessary in order to provide armed security guard services at the County of Summit Veterans
43 Service Commission Building.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
