7 **A Resolution authorizing the County Executive to execute any documents necessary to accept**  
8 **an award of a grant from the Ohio Department of Public Safety - Ohio Traffic Safety Office**  
9 **for a countywide Operating a Motor Vehicle While Intoxicated Task Force program for the**  
10 **period 10/1/15 through 9/30/16, in the amount of \$224,975.43, with no local cash match**  
11 **requirement, confirming an award by the Board of Control of a general encumbrance super**  
12 **blanket purchase order for payments to various law enforcement participating in the Task**  
13 **Force for the period 10/1/15 through 9/30/16, in the amount of \$87,717.50, and appropriating**  
14 **grant funds, for the Sheriff, and declaring an emergency.**

15  
16 WHEREAS, the Ohio Department of Public Safety - Ohio Traffic Safety Office, has awarded  
17 the County Sheriff a grant for a countywide Operating a Motor Vehicle While Intoxicated (“OVI”)  
18 Task Force program, for the period 10/1/15 through 9/30/16, in the amount of \$224,975.43, with no  
19 local cash match requirement, in order to conduct high visibility enforcement, public awareness, and  
20 education for alcohol-related crashes and traffic-related fatalities in Summit County; and

21  
22 WHEREAS, the Board of Control, at its meeting held September 9, 2015, awarded a general  
23 encumbrance super blanket purchase order for payments to various law enforcement participating in  
24 the OVI Task Force for services provided, for the period 10/1/15 through 9/30/16, in the amount of  
25 \$87,717.50, subject to confirmation by County Council; and

27 WHEREAS, it is necessary to appropriate said grant funds, in the amount of \$224,975.43, for  
28 the period 10/1/15 through 12/31/15; and

29  
30 WHEREAS, this Council finds and determines, after reviewing all pertinent information, that  
31 it is necessary and in the best interest of the County of Summit to authorize the County Executive to  
32 execute any documents necessary to accept the aforementioned grant for the OVI Task Force, to  
33 confirm the award by the Board of Control of the aforementioned general encumbrance super  
34 blanket purchase order and to appropriate grant funds;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of  
37 Ohio, that:

41 The County Executive is hereby authorized to execute any documents necessary to accept a  
42 grant for a countywide Operating a Motor Vehicle While Intoxicated (“OVI”) Task Force program,  
43 for the period 10/1/15 through 9/30/16, in the amount of \$224,975.43, with no local cash match  
44 requirement.

48 The award by the Board of Control of a general encumbrance super blanket purchase order  
49 for payments to various law enforcement participating in the OVI Task Force for services provided,  
50 for the period 10/1/15 through 9/30/16, in the amount of \$87,717.50 is hereby confirmed and the  
51 Executive is authorized to execute said purchase order.

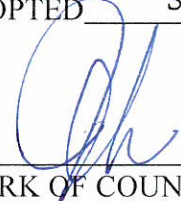
