A Resolution confirming an award by the Board of Control of a construction contract to Matt Winters Excavating, LLC for the repair of the slope under the Granger Road Bridge in Bath Township, in an amount not to exceed \$174,000.00, for the Engineer, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2015-039, which authorized the County Executive to advertise for bids as needed for roadway engineering and construction projects, bridge engineering and construction projects, pavement maintenance projects and vehicles for the County Engineer's 2015 Capital Improvement Program and federal and state funded projects, for an estimated total cost not to exceed \$8,996,619.00; and

WHEREAS, the Board of Control, at its meeting held 9/3/15, awarded a construction contract to Matt Winters Excavating, LLC for the repair of the slope under the Granger Road Bridge in Bath Township, in Council District 5, in an amount not to exceed \$174,000.00, subject to confirmation by County Council; and

WHEREAS, this Council previously adopted Resolution No. 2015-023, which adopted the County of Summit Capital Improvements Program for 2015-2020 and appropriated \$7,810,688.41 for projects in the 2015 Capital Improvement Program for the Executive's Department of Finance and Budget; and

WHEREAS, this Council previously adopted Resolution No. 2015-312 authorizing the County Executive to execute agreements for the acquisition of a channel easement for the repair of the Granger Road Bridge located in Bath Township; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with Matt Winters Excavating, LLC. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a construction contract to Matt Winters Excavating, LLC. for the repair of the slope under the Granger Road Bridge located in Bath Township, in Council District 5, in an amount not to exceed \$174,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such construction contract.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately provide for completion of the repair of the slope under the Granger Road Bridge in Bath Township.
