7 **A Resolution appropriating funds in the amount of \$88,613.38 in the Board of**  
8 **Developmental Disabilities-Operating Fund and funds in the amount of \$150,000.00 in the**  
9 **Board of Developmental Disabilities-Consolidated Donations Fund for a total**  
10 **appropriation of \$238,613.38, for the Board of Developmental Disabilities, and declaring an**  
11 **emergency.**

13 WHEREAS, the Board of Developmental Disabilities has a Consolidated Donations Fund  
14 (20813) separate from the Operating Fund (20801) which will require both an appropriation in  
15 the Operating Fund to transfer funds to the Consolidated Donations Fund in the amount of  
16 \$88,613.38 and an appropriation in the Consolidated Donations Fund to pay miscellaneous  
17 expenditures out of the Consolidated Donations Fund in the amount of \$150,000.00; and

19 WHEREAS, this Council has determined by reviewing all pertinent information that the  
20 aforementioned appropriations are necessary and in the best interest of the County of Summit;
