7 **A Resolution confirming an award by the Board of Control of a professional service**

12 WHEREAS, the Board of Control, at its meeting held February 24, 2010, awarded a
13 contract renewal to provide the aforementioned agreement, subject to confirmation by County
14 Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a professional service contract with the County of
25 Summit Domestic Relations Court, for the IV-D service provider agreement, for the period
26 1/1/10 to 12/31/10, in an amount not to exceed \$622,300.00, is hereby confirmed and the County
27 Executive is hereby authorized to execute such agreement.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the aforementioned agreement.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
