7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled, "Temporary Hiring Freeze," to authorize the Sheriff to hire an external**
9 **person into the full-time non-bargaining unclassified position of Director of**
10 **Administration-Legal-SHF, at a salary not to exceed the midpoint of \$77,209.60 annually,**
11 **for the Sheriff, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted
14 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary
15 Hiring Freeze," to control and reduce the County's budget deficit; and

16
17 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
18 the filling of an existing position by hiring an employee is necessary for the effective and
19 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
20 said employee; and

22 WHEREAS, on November 3, 2009, Christine Croce was elected Barberton Municipal
23 Court Clerk and thereafter, left her full-time non-bargaining unclassified position in the County
24 Sheriff's Office as a Director of Administration-Legal-SHF; and

26 WHEREAS, the aforementioned position has been vacant for over a year and the Sheriff
27 has identified the need for the position to be filled in order to effectively operate his office; and

29 WHEREAS, the Sheriff wishes to hire an external person into the full-time non-
30 bargaining unclassified position of Director of Administration-Legal-SHF, at a salary not to
31 exceed the midpoint of \$77,209.60 annually; and

33 WHEREAS, there is an available vacancy in the position of Director of Administration-
34 Legal-SHF, in the Sheriff's Office pursuant to the Staffing Report for 2010 approved by this
35 Council through the adoption of Amended Resolution 2009-501;

37 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
38 is necessary and in the best interest of the County of Summit to authorize the Sheriff to hire an
39 external person into the full-time non-bargaining unclassified position of Director of
40 Administration-Legal-SHF, at a salary not to exceed the midpoint of \$77,209.60 annually;

42 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
43 State of Ohio, that:

47 County Council hereby determines that the Sheriff has demonstrated that it is necessary
48 for the effective and continued operation of his office to authorize the Sheriff, pursuant to
49 Section 169.04(j) of the Codified Ordinance, to hire an external person into the full-time non-
50 bargaining unclassified position of Director of Administration-Legal-SHF, at a salary not to
51 exceed the midpoint of \$77,209.60 annually.

57 This Resolution is hereby declared an emergency in the interest of the health, safety and
58 welfare of the citizens of the County of Summit and for the further reason to immediately
59 authorize the County Sheriff to hire a Director of Administration-Legal-SHF in order to continue
60 to effectively operate the Sheriff's Office.

64 Provided this Resolution receives the affirmative vote of eight members, it shall take
65 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
66 and be in force at the earliest time provided by law.

70 It is found and determined that all formal actions of this Council concerning and relating
71 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
72 deliberations of this Council and of any of its committees that resulted in such formal action,
73 were in meetings open to the public, in compliance with all legal requirements, including Section
74 121.22 of the Ohio Revised Code.
