7 **A Resolution authorizing the County Executive to advertise for bids for the Men's**  
8 **Community Based Correctional Facility ("CBCF) Renovation Project, for an estimated**  
9 **total cost not to exceed \$85,000.00, for the Executive's Department of Administrative**  
10 **Services-Physical Plants, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for the Men's CBCF  
16 Renovation Project, for an estimated total cost not to exceed \$85,000.00; and

18 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of  
19 Council; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that is  
22 necessary and in the best interest of the County of Summit to authorize the Executive to advertise  
23 for bids for the aforementioned project;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that;

30 The County Executive is authorized to advertise for bids for the Men's Community  
31 Based Correctional Facility ("CBCF") Renovation Project for an estimated total cost not to  
32 exceed \$85,000.00.

34 SECTION 2

36 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
37 of the citizens of the County of Summit, and for the further reason that it immediately authorizes  
38 the Executive to advertise for bids for the CBCF Renovation Project.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take  
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating  
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
50 deliberations of this Council and any of its committees that resulted in such formal action, were  
51 in meetings open to the public, in compliance with all legal requirements, including Section  
52 121.22 of the Ohio Revised Code.
