7 **A Resolution certifying deferred sewer tap-in fees to the Fiscal Officer, for the Executive's**

10 WHEREAS, Section 923.05(c) of Title V of the Codified Ordinances provides for the  
11 certification of sewer tap-in fees under the extended payment program administered by the  
12 Executive's Department of Environmental Services; and

14 WHEREAS, Section 923.05(c) of Title V of the Codified Ordinances provides that these  
15 charges are to be certified to the Fiscal Officer and placed on the property tax duplicate for  
16 collection; and

18 WHEREAS, this Council has determined by reviewing all the pertinent information that  
19 certifying the aforementioned charges to the Fiscal Officer is necessary and in the best interests  
20 of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

27 The sewer tap-in fees of the following participants in the County's extended payment  
28 program for financially disadvantaged residents, charitable agencies and public institutions are  
29 certified to the Fiscal Officer to be placed on the tax list and duplicate and collected as other  
30 taxes are collected in five annual installments, payable semiannually without interest, as  
31 provided by Section 923.05(c) of Title V of the Codified Ordinances and Section 6117.02(B) of  
32 the Ohio Revised Code.
