8 **Development (“ODOD”) for the Ohio Job Ready Sites (“JRS”) administrative costs, in the**

12 WHEREAS, a Memorandum of Understanding (“MOU”) exists between the ODOD and
13 the County of Summit which defines the agreement for an “Application Review Assistance
14 under the JRS which will result in the County receiving up to \$5,000.00 per program round for
15 administrative services; and

17 WHEREAS, two JRS program rounds have been completed, and the County Executive’s
18 Department of Community and Economic Development is in receipt of \$10,000.00 from ODOD;

22 necessary and in the best interest of the County of Summit to appropriate the aforementioned
23 funds in the amount of \$10,000.00;
