7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a revised State Fiscal Year (“SFY”) 2011 One Stop Resource Sharing Allocation**
9 **award for Workforce Investment Act (“WIA”) Area 20, in the amount of \$204,429.00, in**
10 **federal pass-through funds from the Ohio Department of Job and Family Services**
11 **(“ODJFS”), with no local cash match requirement, effective 7/1/10 through 6/30/11, for the**
12 **Executive’s Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, ODJFS, formerly known as the Ohio Bureau of Employment Services, has
15 mandatory ODJFS staffing located on site in Summit County at the WIA Area 20 One Stop
16 Resource Center; and

18 WHEREAS, ODJFS has awarded a SFY 2011 One Stop Resource Sharing Allocation in
19 the amount of \$204,429.00 to Summit County Department of Job and Family Services, for the
20 State’s share of space occupied by ODJFS at the WIA Area 20 One Stop Resource Center; and

22 WHEREAS, this Council has determined by reviewing all pertinent information that it is
23 necessary and in the best interest of the County of Summit to authorize the Executive to execute
24 any documents necessary to accept the aforementioned award from the Ohio Department of Job
25 and Family Services;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The County Executive is hereby authorized to execute any documents necessary to accept
33 the award from the Ohio Department of Job and Family Services of a State Fiscal Year 2011 One
34 Stop Resource Sharing Allocation award for Workforce Investment Area 20, in the amount of
35 \$204,429.00, with no local cash match requirement.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit and for the further reason of immediately
41 accepting the SFY 2011 One Stop Resource Sharing Allocation award for the County.

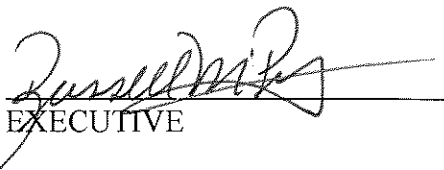
