7 **A Resolution authorizing the Executive, through the Department of Job and Family**
8 **Services, to transfer an amount not to exceed \$718,797.00 in TANF/Title XX funds to**
9 **Summit County Children Services, and to execute any documents necessary to effectuate**
10 **said transfer, for the Executive's Department of Job and Family Services, and declaring an**
11 **emergency.**

13 WHEREAS, the Department of Job and Family Services ("DJFS") is the recipient of
14 certain TANF/Title XX funds, which it receives as part of its annual TANF allocation, and which
15 reduces its annual TANF allocation by the amount set aside for TANF/Title XX; and

16
17 WHEREAS, on July 9, 2010, DJFS received an allocation notice from the State, whereby
18 the State set forth the TANF allocations for DJFS for the time period of July 1, 2010 through
19 September 30, 2010; and

21 WHEREAS, the July 9, 2010 allocation notice indicates that DJFS has been allocated
22 TANF/Title XX funds in the amount of \$718,797.00 for the period of July 1, 2010 through
23 September 30, 2010, said amount to be part of, and to be taken out of, DJFS's TANF allocation
24 from the State; and

26 WHEREAS, DJFS currently anticipates an unexpected balance of TANF funds upon the
27 close of business on September 30, 2010, and has taken several recent steps to reduce that TANF
28 balance; and

30 WHEREAS, to further reduce said balance, to provide additional funding to Summit
31 County Children Services ("SCCS"), to allow for additional services to be provided to children
32 and families in Summit County by SCCS, and to ensure that said funds remain in Summit
33 County to benefit Summit County residents, DJFS has proposed that an amount not to exceed
34 \$718,797.00 be transferred out of the County's TANF allocation to SCCS for use as TANF/Title
35 XX funds for Non-Allocated Children's Services costs, which is a permitted TANF/Title XX
36 expenditure; and

38 WHEREAS, this Council finds and determines that it is necessary and in the best interest
39 of the County to authorize the transfer of an amount not to exceed \$718,797.00 of TANF/Title
40 XX funds to SCCS, and to authorize the executive to execute any documents necessary to
41 effectuate said transfer.

43 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
44 State of Ohio, that:

48 The County Executive, through the Department of Job and Family Services, is hereby
49 authorized to transfer an amount not to exceed \$718,797.00 in TANF/Title XX funds to Summit
50 County Children Services ("SCCS") to be used for Non-Allocated Children's Services costs, and
51 the County Executive is further authorized to execute any documents necessary to effectuate said
52 transfer.
