7 **A Resolution authorizing the County Executive to pay Eric Yurchisin the sum of**  
8 **\$19,270.33 for costs of repair and restoration to the basement and loss of his personal**  
9 **property resulting from a sewer backup at his residence on 176 North Oakmont Road,**  
10 **Northfield, Ohio 44067, in Council District 1, for the Executive's Department of**  
11 **Environmental Services, and declaring an emergency.**

12  
13 WHEREAS, on August 14, 2010, a sewer backup occurred at the residence of Eric  
14 Yurchisin at 176 North Oakmont Road, in the City of Northfield, in Council District 1, and

15  
16 WHEREAS, the personal property lost is valued at 4,981.50, and the cost to repair the  
17 damage to the basement of Mr. Yurchisin's residence is \$14,288.83, excluding costs of sanitizing  
18 and dry-out being paid under Chapter 119A of the Codified Ordinances of the County of  
19 Summit, and

21 WHEREAS, this Council finds and determines after reviewing all pertinent information  
22 that authorizing the Executive to pay the sum of \$19,270.33 to Eric Yurchisin is necessary and in  
23 the best interest of the County;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that:

28 SECTION 1

30 The County Executive is hereby authorized to pay to Eric Yurchisin the sum of  
31 \$19,270.33 to reimburse him for the repair and restoration of his basement at 176 North  
32 Oakmont Road, in the City of Northfield, in Council District 1, and for the value of personal  
33 property lost in the sewer backup on August 14, 2010, and to prepare a release and other  
34 documents necessary to protect the interests of the County with said reimbursement.

38 The payment authorized in Section 1 shall be paid out of the Executive's Department of  
39 Environmental Services' Sewer Fund, account number 50001-8510-61017.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and welfare  
44 of the citizens of the County of Summit, and for the further reason that it will immediately allow  
45 said payment.
