8 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
9 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**
10 **two external, part-time, unclassified, Direct Indictment Officer I positions, at a rate of pay**
11 **of \$14.90 per hour for 25 hours of work per week each, to replace a full-time, unclassified,**
12 **Direct Indictment Officer I position that is currently vacant, to be funded in full through**
13 **the Direct Indictment Agreement with the City of Akron, for the Prosecutor, and declaring**
14 **an emergency.**

16 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted
17 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary
18 Hiring Freeze," to control and reduce the County's budget deficit; and

19
20 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
21 the filling of an existing position by hiring an employee is necessary for the effective and
22 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
23 said employees; and

25 WHEREAS, due to separation through resignation of a full-time, unclassified, Direct
26 Indictment Officer I, the Prosecutor states that it is necessary for the continued and effective
27 operation of her office to be permitted to hire and fill this vacancy with two part-time,
28 unclassified Direct Indictment Officer I positions; and

30 WHEREAS, this Council has determined, by reviewing all pertinent information, that it
31 is necessary and in the best interest of the County of Summit to authorize the County Prosecutor
32 to hire two part-time, unclassified Direct Indictment Officer I positions;

34 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
35 State of Ohio, that:

39 County Council hereby determines that the County Prosecutor has demonstrated that it is
40 necessary for the effective and continued operation of her office to authorize the County
41 Prosecutor, pursuant to Section 169.04(j) of the Codified Ordinances, to hire two part-time,
42 unclassified Direct Indictment Officer I positions, at a rate of pay of \$14.90 per hour for 25 hours
43 per week each, to be funded in full through the Direct Indictment Agreement with the City of
44 Akron.

48 This Resolution is hereby declared an emergency in the interest of the health, safety and
49 welfare of the citizens of the County of Summit and for the further reason to immediately
50 authorize the County Prosecutor to hire said individuals in order to continue effectively
51 prosecuting cases and collect revenue for Summit County.

SECTION 4


