7 **A Resolution appropriating \$75,000.00, for a Stimulus Special Project Allocation for**  
8 **Workforce Investment Act ("WIA") Area 2/20 for Medina County, from the State of Ohio**  
9 **Department of Job and Family Services ("ODJFS"), made available through the American**  
10 **Recovery and Reinvestment Act of 2009 ("ARRA"), with no local cash match requirement,**  
11 **for a grant period from 1/1/11 through 6/30/11, for the Executive's Department of Job and**  
12 **Family Services, and declaring an emergency.**

13  
14 WHEREAS, pursuant to Resolution No. 2009-088, the County Executive is authorized to  
15 execute any documents necessary to accept funds made available by the ARRA (Public Law  
16 111-5), signed into law by President Obama on 2/27/09, including executing and submitting a  
17 substantial amendment to the Annual Action Plan, but said funds must be appropriated prior to  
18 being spent; and

20 WHEREAS, the Executive's Department of Job and Family Services ("DJFS") is the  
21 state-designated fiscal agent to coordinate and monitor the state-approved WIA programs for  
22 Summit and Medina counties; and

24 WHEREAS, ODJFS has awarded a WIA Area 2/20 Stimulus Special Project funds grant  
25 in the amount of \$75,000.00, with no local cash match requirement, for a grant period from  
26 1/1/11 to 6/30/11, for Medina County for the purpose of providing funding for an Entry Level  
27 Manufacturing Certification Pilot Project in calendar year 2011; and

29 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
30 necessary and in the best interest of the County of Summit to appropriate the aforementioned  
31 funds in the amount of \$75,000.00 received from ODJFS ARRA WIA funding;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
