11 WHEREAS, the Board of Control, at its meeting held February 2, 2011, awarded a
12 purchase order to provide the aforementioned uniform allowance, subject to confirmation by
13 County Council; and,

15 WHEREAS, County Council has determined by reviewing all pertinent information that
16 the purchase order is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
19 of Ohio, that:

23 The award by the Board of Control of a purchase order with D&G Uniforms for deputies'
24 uniform allowance, per bargaining agreement, as Best Practical Source, in an amount not to
25 exceed \$96,000.00, is hereby confirmed and the County Executive is hereby authorized to
26 execute such purchase order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the aforementioned uniform allowance.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,
