21	the enterprise zone agreement be amended by reducing the incentive level to 40% from 50%; and

24	accepting the recommendations of the Tax Incentives Review Council, which included amending
25	the enterprise zone agreement for GED Integrated Solutions, Inc., and

27	WHEREAS, on June 23, 2010, the Council of the City of Twinsburg passed Resolution
28	No. 93-2010 amending the incentive level for GED Integrated Solutions, Inc., to 40%; and
