7 **A Resolution authorizing the County Executive to advertise for bids for the Executive's**
8 **Department of Environmental Services ("DOES") Facility Parking Deck Repair Project, in**
9 **Council District 2, for an estimated total cost not to exceed \$90,000.00, for the Executive's**
10 **Department of Administrative Services-Physical Plants, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Executive's DOES
16 Facility Parking Deck Repair Project, in Council District 2, for an estimated total cost not to
17 exceed \$90,000.00; and

19 WHEREAS, the cost of the aforementioned contract shall be paid from DOES funds; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that is
22 necessary and in the best interest of the County of Summit to authorize the Executive to advertise
23 for bids for the aforementioned project;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is authorized to advertise for bids for the Executive's Department
31 of Environmental Services ("DOES") Facility Parking Deck Repair Project, in Council District
32 2, for an estimated total cost not to exceed \$90,000.00.

36 This Resolution is declared an emergency in the interest of the health, safety, and welfare
37 of the citizens of the County of Summit, and for the further purpose that it immediately
38 authorizes the Executive to advertise for bids for the DOES Facility Parking Deck Repair

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
