A Resolution authorizing the County Executive to prepare and submit an application with the Ohio Public Works Commission ("OPWC") for a grant to be used to finance the cost of the Massillon Road Sanitary Sewer Rehabilitation Project Q-951 ("Project"), located in the City of Green, Council District 8, for the Executive's Department of Environmental Services, and declaring an emergency.

WHEREAS, the State Capital Improvements Program provides financial assistance to political subdivisions for capital improvement projects to public infrastructure; and

WHEREAS, the County desires to apply for a grant from the OPWC to finance the cost of the Project, which will consist of the rehabilitation of approximately 2,626 feet of 24-inch reinforced concrete pipe, for a total project cost of approximately \$520,000.00; and

WHEREAS, County Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County to apply for said funds and to authorize the execution of any necessary agreements and associated documents;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is authorized to prepare and submit an application and associated documents to the Ohio Public Works Commission ("OPWC") to obtain a grant to finance the Massillon Road Sanitary Sewer Rehabilitation Project Q-951 ("Project"), located in the City of Green, Council District 8.

SECTION 2

The terms of said application and associated documents shall maximize the requested amount of State Issue 1 funds, with the remainder of the cost of the improvements to be borne by the County of Summit through the Executive's Department of Environmental Services Capital Improvements Program funding, with a total estimated cost to the County of \$260,000.00.
