7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 with the**
8 **County of Summit Court of Common Pleas, Juvenile Division, for an extension of Family**
9 **Resource Center services, for the period 7/1/11 to 9/30/11, for families involved with the**
10 **Court, in an amount not to exceed \$85,000.00 (25% increase), for the Executive's**
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 25, 2011, awarded a change
14 order to provide the aforementioned services, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the change order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of Change Order No. 1 with the County of Summit
25 Court of Common Pleas, Juvenile Division, for an extension of Family Resource Center services,
26 for the period 7/1/11 to 9/30/11, for families involved with the Court, in an amount not to exceed
27 \$85,000.00 (25% increase), is hereby confirmed and the County Executive is hereby authorized
28 to execute such change order.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.
