23 The award by the Board of Control of change orders to certain professional service
24 contracts for Workforce Investment Act youth services, for the period 7/1/11 to 9/30/11, for a
25 total cumulative increase not to exceed \$256,250.00, as more fully set forth on Exhibit A,
26 attached hereto and incorporated herein, is hereby confirmed, and the County Executive is
27 authorized to execute such change orders.

31 This Resolution is hereby declared an emergency in the interest of the health, safety, and
32 welfare of the citizens of the County of Summit and for the further reason of immediately
33 providing such services.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
