7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Fiscal Officer to**
9 **hire externally a full-time unclassified Assistant Fiscal Officer at a rate not to exceed \$33.45**
10 **per hour, the midpoint of the salary range, for the Fiscal Officer, and declaring an**
11 **emergency.**

13 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted
14 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled
15 "Temporary Hiring Freeze," as a budgetary control measure; and

16
17 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
18 the filling of an existing position by hiring an employee is necessary for the effective and
19 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
20 said employee; and

22 WHEREAS, as a result of reduced staffing over the last several years and in order to
23 ensure the effective and continued operation of the Fiscal Office, the Fiscal Officer has requested
24 authority to hire externally a full-time unclassified Assistant Fiscal Officer at a rate not to exceed
25 \$33.45 per hour, the midpoint of the salary range; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is
28 necessary and in the best interest of the County of Summit to authorize the Fiscal Officer to hire
29 externally a full-time unclassified Assistant Fiscal Officer at a rate not to exceed \$33.45 per
30 hour, the midpoint of the salary range;

32 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
33 that:

37 County Council hereby determines that it is necessary for the continued and effective
38 operation of the County Fiscal Office, and further authorizes the County Fiscal Officer to hire
39 externally a full-time unclassified Assistant Fiscal Officer at a rate not to exceed \$33.45 per
40 hour, the midpoint of the salary range.

44 This Resolution is hereby declared to be an emergency in the interest of the health, safety
45 and welfare of the citizens of the County of Summit and for the further reason that it is necessary
46 to immediately authorize the external hiring of an Assistant Fiscal Officer.
