7 **A Resolution confirming an award by the Board of Control of various professional service**
8 **contract renewals, per attached Exhibit A, for employment services to adults with a non-**

10 **exceed \$240,000.00, for the Executive's Department of Job and Family Services, and**

13 WHEREAS, the Board of Control, at its meeting held August 24, 2011, awarded contract
14 renewals, per attached Exhibit A, to provide the aforementioned services, subject to confirmation
15 by County Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the contract renewals are necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of various professional service contract renewals, per
26 attached Exhibit A, for employment services to adults with a non-violent felony criminal record,
27 for the period 10/1/11 to 6/30/12, in a total amount not to exceed \$240,000.00, is hereby
28 confirmed and the County Executive is hereby authorized to execute such contract renewals.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further purpose to immediately
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,


