A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled "Temporary Hiring Freeze," to authorize the County Sheriff to hire one external person into the full-time classified position of Civil Clerk I, at an annual salary of \$23,296.00, the minimum salary for the position, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Ordinance No. 2009-110, which enacted Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled, "Temporary Hiring Freeze," to control and reduce the County's budget deficit and Ordinance No. 2011-204, which reinstituted the hiring freeze through December 31, 2012; and

WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that the filling of an existing position by hiring an employee is necessary for the effective and continued operation of the office, Council may adopt a Resolution authorizing the office to hire said employees; and

WHEREAS, the County Sheriff says it is necessary for the continued and effective operation of his Civil Division, to be permitted to hire one external person into the full-time classified position of Civil Clerk I, at an annual salary of \$23,296.00, the minimum salary for Civil Clerk I; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Sheriff to hire one external person into the full-time classified position of Civil Clerk I, at the aforementioned annual salary;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

County Council hereby determines that the County Executive has demonstrated that it is necessary for the effective and continued operation of the office to authorize the Sheriff, pursuant to Section 169.04(j) of the Codified Ordinance, to hire one external person into the full-time classified position of Civil Clerk I, at an annual salary of \$23,296.00, the minimum salary for the position.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason to immediately authorize the County Sheriff to hire one external person into the full-time classified position of Civil Clerk I, for the continued and effective operation of the Civil Division for the Summit County Sheriff's Office.
