7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled, "Temporary Hiring Freeze," to authorize the County Executive to hire**
9 **one external person into the full-time classified position of Account Clerk 2, at an annual**
10 **salary of \$32,177.60, the midpoint rate of the salary range for the position, and to hire one**
11 **external person into the full-time classified position of Fiscal Officer 2, at an annual salary**
12 **of \$45,000.00, below the midpoint rate of the salary range for the position, for the**
13 **Executive, and declaring an emergency.**

15 WHEREAS, County Council previously adopted Ordinance No. 2009-110, which
16 enacted Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled,
17 "Temporary Hiring Freeze," to control and reduce the County's budget deficit and Ordinance
18 No. 2011-204, which reinstated the hiring freeze through December 31, 2012; and

20 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
21 the filling of an existing position by hiring an employee is necessary for the effective and
22 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
23 said employees; and

25 WHEREAS, the County Executive says it is necessary for the continued and effective
26 operation of his Department of Finance and Budget, which has reduced its General Fund salary
27 budget line item by 47% since 2009, to be permitted to hire one external person into the full-time
28 classified position of Account Clerk 2, at an annual salary of \$32,177.60, the midpoint rate of the
29 salary range for the position, and to hire one external person into the full-time classified position
30 of Fiscal Officer 2, at an annual salary of \$45,000.00, below the midpoint rate of the salary range
31 for the position; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County of Summit to authorize the County
35 Executive to hire one external person into the full-time classified position of Account Clerk 2,
36 and one external person into the full-time classified position of Fiscal Officer 2, at the
37 aforementioned annual salaries;

39 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
40 State of Ohio, that:

44 County Council hereby determines that the County Executive has demonstrated that it is
45 necessary for the effective and continued operation of the office to authorize the Executive,
46 pursuant to Section 169.04(j) of the Codified Ordinance, to hire one external person into the full-
47 time classified position of Account Clerk 2, at an annual salary of \$32,177.60, the midpoint rate
48 of the salary range for the position, and to hire one external person into the full-time classified
49 position of Fiscal Officer 2, at an annual salary of \$45,000.00, below the midpoint rate of the
50 salary range for the position.


