7 **A Resolution confirming an award by the Board of Control of a purchase order with Ports**  
8 **Petroleum Company, Inc., for purchases of diesel fuel and bulk shipments of gasoline for**  
9 **fleet operation and emergency power generators, under CUE pricing, in an amount not to**  
10 **exceed \$150,000.00, for the Executive's Department of Environmental Services, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 7, 2012, awarded a purchase  
14 order for purchases of diesel fuel and bulk shipments of gasoline for fleet operation and  
15 emergency power generators, under CUE pricing, subject to confirmation by County Council;  
16 and,

18 WHEREAS, County Council has determined by reviewing all pertinent information that  
19 the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a purchase order with Ports Petroleum Company,  
27 Inc., for purchases of diesel fuel and bulk shipments of gasoline for fleet operation and  
28 emergency power generators, under CUE pricing, in an amount not to exceed \$150,000.00, is  
29 hereby confirmed and the County Executive is hereby authorized to execute such purchase order.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and for the further reason to immediately  
35 provide the aforementioned diesel fuel and gasoline before the current purchase order expires  
36 3/15/12.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.




