WHEREAS, on January 26, 2012, the Planning Commission approved a subdivision titled "Natures Preserve Phase I", concerning a subdivision located in Twinsburg Township; and

WHEREAS, under Section 1104.06 (b) (4) of the Codified Ordinances of the County of Summit and Section 711.041 of the Ohio Revised Code, the approval of this Council is a prerequisite for the recording of said plat; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the acceptance and approval of the aforementioned replat is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of Ohio, that;

## **SECTION 1**

The subdivision, together with restrictions, covenants, and easements thereon, is hereby accepted by the County of Summit, to be recorded by the County Fiscal Officer. The subdivision shall be known as the "Natures Preserve Phase I," and is located in Twinsburg Township, County of Summit, Council District 1.

## **SECTION 2**

The following performance bond furnished by <u>American Contractors Indemnity Company</u> in the amount of \$851,325.00, having been submitted and approved, was accepted in conjunction with the "Natures Preserve Phase I." The documents are to be retained by the County Executive, who is authorized to release said bond, in part or in full, upon satisfactory completion of the obligations set forth. Additionally, the acceptance of the subdivision and associated plat is granted in reliance upon the developer's representations in Exhibit A, wherein the developer agrees not to transfer any of the lots in the subdivision until such time as a letter of credit or performance bond is provided by the developer ensuring completion of the sanitary sewer improvements or the same are completed by the developer.

## **SECTION 3**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it immediately facilitates development in Twinsburg Township.
