7 **A Resolution confirming an award by the Board of Control of a purchase order with Metro**  
8 **Regional Transit Authority for bus passes for Temporary Assistance to Needy Families and**  
9 **Food Stamp Education and Training work-mandated clients, for the period 7/1/11 through**  
10 **12/31/11, as Best Practical Source, in an amount not to exceed \$52,210.00, for the**  
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held January 25, 2012, awarded a  
14 purchase order with Metro Regional Transit Authority for bus passes for Temporary Assistance  
15 to Needy Families and Food Stamp Education and Training work-mandated clients, for the  
16 period 7/1/11 through 12/31/11, as Best Practical Source, in an amount not to exceed \$52,210.00,  
17 subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the aforementioned purchase order is necessary and in the best interest of the County of  
21 Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

28 The award by the Board of Control of a purchase order with Metro Regional Transit  
29 Authority for bus passes for Temporary Assistance to Needy Families and Food Stamp  
30 Education and Training work-mandated clients, for the period 7/1/11 through 12/31/11, as Best  
31 Practical Source, in an amount not to exceed \$52,210.00, is hereby confirmed and the County  
32 Executive is hereby authorized to execute such purchase order.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
38 providing prompt payment to Metro Regional Authority.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take  
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating  
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
50 deliberations of this Council and of any of its committees that resulted in such formal action,  
51 were in meetings open to the public, in compliance with all legal requirements, including Section  
52 121.22 of the Ohio Revised Code.


