WHEREAS, the Ohio Office of Public Safety/Office of Criminal Justice Services has awarded a Justice Assistance Grant ("JAG"), to the Summit County Drug Unit program, in the amount of \$76,913.10, which requires a 25% local cash match of \$25,637.70, for a project total of \$102,550.80 for the period 1/1/12 through 12/31/12; and

WHEREAS, this annual funding supports a Sheriff's captain position for the Drug Unit operations; and

WHEREAS, the local cash match funding will be paid from the Sheriff's Drug Unit checking account funds; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned grant from the Ohio Office of Public Safety/Office of Criminal Justice Services, and to appropriate these grant funds;
