7 **A Resolution confirming the award by the Board of Control a renewal (3rd of 5) of a**
8 **purchase contract with Aramark Correctional Services, LLC for inmate food services for**
9 **the County of Summit Jail, for a one-year term, from 12/01/12 to 11/30/13, in an amount**
10 **not to exceed \$760,000.00, for the Sheriff, and declaring an emergency.**

12 WHEREAS, County Council previously adopted Resolution No. 2011-542, which
13 authorized the County Executive to execute a renewal (2nd of 3) of a purchase contract with
14 Aramark Correctional Services, LLC, subject to the approval of the Board of Control, as a Best
15 Practical Source, for inmate food services for the County of Summit Jail, for a one-year term,
16 from 12/1/11 to 11/30/12, in an amount not to exceed \$740,000.00, and authorizing an additional
17 two options to renew the contract for an additional one-year term, for five total options to renew;

20 WHEREAS, the Board of Control, at its meeting held on November 21, 2012 awarded a
21 renewal (3rd of 5) of the aforementioned purchase contract with Aramark Correctional Services,
22 LLC for a one-year term, from 12/01/12 to 11/30/13, in an amount not to exceed \$760,000.00,
23 subject to confirmation by County Council; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to the award by the Board of
27 Control a renewal (3rd of 5) of the aforementioned purchase contract with Aramark Correctional
28 Services, LLC;

30 NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the County of
31 Summit, State of Ohio, that:

34 The award by the Board of Control a renewal (3rd of 5) of a purchase contract with
35 Aramark Correctional Services, LLC for inmate food services for the County of Summit Jail, for
36 a one-year term, from 12/01/12 to 11/30/13, in an amount not to exceed \$760,000.00, is hereby
37 confirmed and the County Executive is authorized to execute such contract.

41 This Resolution is hereby declared to be an emergency measure in the interest of the
42 health, safety and welfare of the citizens of the County of Summit, Ohio, and for the further
43 reason that it is immediately necessary in order for the County to provide meals to inmates at the
44 County Jail from 2012-2013.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
