8 **A Resolution confirming an award by the Board of Control of a construction contract with**
9 **Karvo Paving for Part 1 of the Riverview Road Resurfacing Project, in Council District 1,**
10 **as lowest responsive and responsible bidder, and appropriating an amount not to exceed**
11 **\$812,598.34, for the period ending December 31, 2012, for the Engineer, and declaring an**
12 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held October 24, 2012, awarded a
14 construction contract with Karvo Paving for Part 1 of the Riverview Road Resurfacing Project,
15 in Council District 1, as lowest responsive and responsible bidder, and appropriating an amount
16 not to exceed \$812,598.34, for the period ending December 31, 2012, subject to confirmation by
17 County Council; and

19 WHEREAS, this project is eligible for \$650,078.67 in Federal Highway Administration
20 funds from the State of Ohio's Department of Transportation, and covers the resurfacing of
21 Riverview Road from Cuyahoga Falls north corporation limit to Peninsula south corporation
22 limit; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that the contract is necessary and the appropriation of the aforementioned funds in the amount of
26 \$812,598.34, for the period ending December 31, 2012, is necessary and in the best interest of
27 the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 The award by the Board of Control of a construction contract with Karvo Paving for Part
35 1 of the Riverview Road Resurfacing Project, in Council District 1, as lowest responsive and
36 responsible bidder, and appropriating an amount not to exceed \$812,598.34, for the period
37 ending December 31, 2012, is hereby confirmed and the County Executive is hereby authorized
38 to execute such contract.
