13 purchase contract renewal (first of three) to provide inmate pay phone services at the County of
14 Summit Jail, for the period 7/15/12 through 7/14/13; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the contract renewal is necessary and in the best interest of the County of Summit;

24 The County Executive is hereby authorized to execute a purchase contract renewal (first
25 of three) with ICSolutions, for inmate pay phone services at the County of Summit Jail, for the
26 period 7/15/12 through 7/14/13, at a commission rate of 70%, is hereby confirmed and the
27 County Executive is hereby authorized to execute such renewal.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further purpose to immediately
33 provide inmate phone services at the County Jail effective 7/15/12.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
