A Resolution authorizing the Executive to execute an agreement with the State of Ohio for a \$100,000.00 Local Government Innovation Fund grant, authorizing associated agreements for services to be performed pursuant to the grant, and appropriating said grant funds for the period of 10/1/12 to 12/31/12, for the Executive, and declaring an emergency.

WHEREAS, pursuant to Resolution No. 2012-060, this Council authorized the Executive to execute and submit an application by the County and other participating entities to the State of Ohio for a \$100,000.00 Local Government Innovation Fund grant, for what has subsequently become known as the Summit County Broadband Initiative; and

WHEREAS, on July 9, 2012, the State of Ohio awarded the County of Summit a \$100,000.00 Local Government Innovation Fund grant for the Summit County Broadband Initiative, and has requested that the County enter into a grant agreement for receipt of said funds; and

WHEREAS, as contemplated by the grant application, the Executive desires to enter into an addendum to existing agreements with the Sourcing Office, a regional Council of Governments, and Hosted Technology Exchange, an Ohio Limited Liability Company, to perform consulting services related to the grant; and

WHEREAS, the procurement of the services of the Souring Office and Hosted Technology Exchange are exempt from competitive bidding pursuant to Section 177.07(a)(2) and (11) of the Codified Ordinances of the County of Summit; and

WHEREAS, it is further necessary to appropriate the aforementioned grant funds that will be received by the County; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary, and in the best interest of this Council, to authorize the Executive to execute the aforementioned grant agreement with the State of Ohio and the aforementioned addendum with the Sourcing Office and Hosted Technology Exchange and to appropriate the aforementioned grant funds.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

DESCRIPTION INC

The Executive is hereby authorized to execute a grant agreement with the State of Ohio for \$100,000.00 from the Local Government Innovation Fund, pursuant to which the County's local match will consist of \$20,000.00 that the County had previously agreed to pay to Hosted Technology Exchange for telecom and data consulting services; and

## **SECTION 2**

The Executive is hereby authorized to execute and addendum with the Sourcing Office and Hosted Technology Exchange to perform consulting services related to the grant, a copy of which is attached hereto as Exhibit A.
