7 **A Resolution authorizing the County Executive, through the Executive's Department of**  
8 **Job and Family Services, to transfer an amount not to exceed \$250,000.00 in Title XX funds**  
9 **to Summit County Children Services, and to execute any documents necessary to effectuate**  
10 **said transfer, for the Executive's Department of Job and Family Services, and declaring an**  
11 **emergency.**

12  
13 WHEREAS, the County Executive's Department of Job and Family Services ("DJFS") is  
14 the recipient of certain Title XX funds, which it receives as part of its annual allocation; and

15  
16 WHEREAS, on August 3, 2011, DJFS received an allocation notice from the State,  
17 whereby the State set forth the Title XX allocations for DJFS for the time period of October 1,  
18 2011 through September 30, 2012; and

19  
20 WHEREAS, the August 3, 2011 allocation notice indicates that DJFS has been allocated  
21 Title XX funds in the amount of \$1,416,624.00 for the period of October 1, 2011 through  
22 September 30, 2012; and

23  
24 WHEREAS, DJFS and Summit County Children Services ("SCCS") intend to enter into  
25 an intergovernmental agreement, memorandum of understanding, or such similar document, in  
26 order for SCCS to provide protective services for children and emancipating out of foster care  
27 services; and

29 WHEREAS, in exchange for providing such services, DJFS will transfer an amount not  
30 to exceed \$250,000.00 of Title XX funds to SCCS to be used for Non-Allocated Children's  
31 costs; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
34 that it is necessary and in the best interest of the County of Summit to authorize the transfer of an  
35 amount not to exceed \$250,000.00 of Title XX funds to SCCS, and to authorize the Executive to  
36 execute any documents necessary to effectuate said transfer;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
39 of Ohio, that:

41 SECTION 1

43 The County Executive, through the Department of Job and Family Services, is hereby  
44 authorized to transfer an amount not to exceed \$250,000.00 in Title XX funds to Summit County  
45 Children Services ("SCCS") to be used for Non-Allocated Children's Services costs, and the  
46 County Executive is further authorized to execute any documents necessary to effectuate said  
47 transfer.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the citizens of the County of Summit and for the further reason to immediately  
8 authorize the transfer of said Title XX funds to SCCS.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take  
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating  
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
20 deliberations of this Council and of any of its committees that resulted in such formal action,  
21 were in meetings open to the public, in compliance with all legal requirements, including Section  
22 121.22 of the Ohio Revised Code.
