A Resolution adopting the classification, classification specification and salary schedule for the exempt classified position of Training Administrator and EEO Compliance Officer #90932 at the County Executive's Office, for the Executive's Department of Human Resources, and declaring an emergency.

WHEREAS, County Council has the authority pursuant to Article III, Section 3.03(10) of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10, and 169.11 of the Codified Ordinances of the County of Summit, to establish classifications, classification specifications and pay/salary schedules for all County employees; and

WHEREAS, the County Executive requests that the classification, classification specification and salary schedule for the exempt classified position of Training Administrator and EEO Compliance Officer #90932 at the County Executive's Office be approved by this Council to reflect the consolidation of the EEO Compliance Officer and training supervisor functions in that office; and

WHEREAS, at its June 21, 2012 meeting, the County Human Resource Commission ("HRC") approved the creation of the aforementioned and issued HRC Order 12-03 stating the same, which is attached hereto as Exhibit C and incorporated herein as if fully restated;

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to adopt the classification, classification specification and salary schedule for the exempt classified position of Training Administrator and EEO Compliance Officer #90932 at the County Executive's Office;

SECTION 1

The classification for Training Administrator and EEO Compliance Officer #90932 at the County Executive's Office is hereby approved, designated as exempt classified and assigned the salary schedule set forth in Exhibit A, which is attached hereto and incorporated herein as if fully restated.
