7 **A Resolution confirming an award by the Board of Control of a renewal of a purchase**
8 **contract (second of four) with Aramark Correctional Services for food service to the**
9 **detention center, for the period 7/1/12 through 6/30/13, in the amount of \$2.769 per meal**
10 **and \$.542 per snack, for a total amount not to exceed \$300,000.00, for the Court of**
11 **Common Pleas – Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 13, 2012, awarded a renewal
14 of a purchase contract (second of four) with Aramark Correctional Services for food service to
15 the detention center, for the period 7/1/12 through 6/30/13, subject to confirmation by County
16 Council; and,

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract renewal is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a renewal of a purchase contract (second of four)
27 with Aramark Correctional Services for food service to the detention center, for the period 7/1/12
28 through 6/30/13, in the amount of \$2.769 per meal and \$.542 per snack, for a total amount not to
29 exceed \$300,000.00, is hereby confirmed and the County Executive is hereby authorized to
30 execute such contract renewal.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide food services for the period beginning 7/1/12.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.


