SECTION 3

The expenditure of up to \$50,000.00 in County local matching road and bridge funds as the County of Summit's share of the cost of the project is hereby authorized.

SECTION 5

The Clerk of Council is instructed to provide two certified copies of this Resolution to the County Engineer, for submission to the Ohio Public Works Commission with said funding application.

SECTION 6

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it is necessary to immediately authorize the grant application due to the application deadline of June 30, 2012.

SECTION 7

Provided this Resolution receives the affirmative vote of eight (8) members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
