7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award to the County of Summit Juvenile Court of a State Fiscal Year 2013**
9 **Workforce Investment Act grant for youth services from the County of Summit**
10 **Department of Job and Family Services, in the amount of \$125,000.00 in federal funds,**
11 **with no local cash match requirement, with a performance period of 7/1/12 through**
12 **6/30/13, and appropriating these funds for program expenditures, for the period 7/1/12**
13 **through 12/31/12, for the Juvenile Court, and declaring an emergency.**

15 WHEREAS, the County of Summit Department of Job and Family Services ("SCDJFS")
16 has awarded to the County of Summit Juvenile Court a State Fiscal Year ("SFY") 2013
17 Workforce Investment Act ("WIA") grant for youth services, in the amount of \$125,000.00 in
18 federal funds, with no local cash match requirement, with a performance period for the period
19 7/1/12 through 6/30/13; and

21 WHEREAS, this grant is a renewal of WIA grants from SCDJFS first awarded in July
22 2010 and supports a case manager working with parole officers for the youths committed to
23 lengthy stays, to prepare them for their release, and for their transition after release, including
24 education and training, job readiness and placement, with follow-up services; and

26 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute any documents necessary to accept the award of the aforementioned grant from the
29 SCDJFS, and to appropriate these grant funds;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept
37 the award to the County of Summit Juvenile Court of a State Fiscal Year 2013 Workforce
38 Investment Act grant for youth services from the County of Summit Department of Job and
39 Family Services, in the amount of \$125,000.00 in federal funds, with no local cash match
40 requirement, with a performance period of 7/1/12 through 6/30/13, and appropriating these funds
41 for program expenditures, for the period 7/1/12 through 12/31/12.


