7 **A Resolution confirming an award by the Board of Control of a sub-grant agreement**  
8 **between the Executive's Department of Job and Family Services and the Executive's**  
9 **Department of Communications for the Youth Employment for Success ("YES") Program**  
10 **for YES to act a third-party employer for the operation of the 2012 Summer Youth**  
11 **Subsidized Employment Program, for the period of 5/15/12 through 8/31/12, in the amount**  
12 **of \$736,680.00 in Temporary Assistance for Needy Families funds, for the Executive's**  
13 **Department of Job and Family Services, and declaring an emergency.**

15 WHEREAS, this Council previously adopted Resolution No. 2012-191, which authorizes  
16 the County Executive to execute all documents necessary to accept an award from the Ohio  
17 Department of Job and Family Services of Temporary Assistance to Needy Family ("TANF")  
18 funds, in the amount of \$1,236,917.14. for the operation of a summer youth employment  
19 program for TANF-eligible children aged 14-24, and appropriating the same for the period  
20 6/1/12 through 12/31/12; and

22 WHEREAS, the Executive's Department of Job and Family Services wishes to execute a  
23 sub-grant agreement with the Executive's Department of Communications for the Youth  
24 Employment for Success ("YES") Program for YES to act a third-party employer for the  
25 operation of the 2012 Summer Youth Subsidized Employment Program, for the period of  
26 5/15/12 through 8/31/12, in the amount of \$736,680.00 in TANF; and

28 WHEREAS, the Board of Control, at its May 30, 2012 meeting, awarded the  
29 aforementioned sub-grant agreement to the Executive's Department of Communications for the  
30 YES Program; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that the aforementioned sub-grant agreement to the Executives' Department of Communications  
34 necessary and in the best interest of the County of Summit and the Board of Control's award of  
35 the same should be confirmed;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that:

42 The award by the Board of Control of a sub-grant agreement between the Executive's  
43 Department of Job and Family Services and the Executive's Department of Communications for  
44 the Youth Employment for Success ("YES") Program for YES to act a third-party employer for  
45 the operation of the 2012 Summer Youth Subsidized Employment Program, for the period of  
46 5/15/12 through 8/31/12, in the amount of \$736,680.00 in Temporary Assistance for Needy  
47 Families funds is hereby confirmed and the County Executive is hereby authorized to execute  
48 such sub-grant agreement.

7 authorize the Executive to execute a necessary sub-grant agreement to provide funds to YES for  
8 to act as a third-party employer for the operation of the 2012 Summer Youth Subsidized  
9 Employment Program, for the period of 5/15/12 through 8/31/12.

14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.
