12 WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health
13 (“ADM”) Services Board has certified that pass-through grant funds are available, primarily
14 from the State of Ohio Department of Mental Health, in the amount of \$381,404.00, with no
15 local cash match requirement, for the period 1/1/13 through 12/31/13; and

17 WHEREAS, additional court revenues in the amount of \$14,000.00, with no local cash
18 match requirement, are available along with the aforementioned 2013 award; and

20 WHEREAS, the Psycho-Diagnostic Clinic is needed to provide court-ordered evaluations
21 in criminal cases, and the aforementioned monies will be used to reimburse the Clinic for
22 expenditures; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to appropriate the
26 aforementioned grant funds in the total amount of \$395,404.00, with no local cash match
27 requirement;
