7 **A Resolution appropriating carryover federal Workforce Investment Act funds for the**
8 **Youth Employment for Success Youth Work Experience Program, received from the**
9 **Executive's Department of Job and Family Services, in the amount of \$134,067.94, with no**
10 **local cash match requirement, for the period 1/1/13 through 6/30/13, for the Executive's**
11 **Department of Communications, Youth Employment for Success Program, and declaring**
12 **an emergency.**

14 WHEREAS, Resolution Nos. 2012-211 and 2012-276 have approved federal Workforce
15 Investment Act ("WIA") awards from the Executive's Department of Job and Family Services
16 ("DJFS"), to the Youth Employment for Success ("YES") program, for a year-round youth
17 employment program for the State Fiscal Year ending 6/30/13; and

19 WHEREAS, unexpended funds remain in the YES program at calendar year end 2012
20 that must be appropriated through 6/30/13; and

22 WHEREAS, the YES program's objectives are to assist youth in overcoming barriers and
23 achieving academic and career goals by addressing their needs for a work experience, academic
24 support, leadership development, personal guidance, and follow-up services; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to appropriate the
28 aforementioned funds in the amount of \$134,067.94;

20 effect and be in force at the earliest time provided by law.


