7 **A Resolution confirming an award by the Board of Control of a purchase order with Zep**

11 WHEREAS, the Board of Control, at its meeting held December 12, 2012, awarded a
12 purchase order with Zep Sales & Service for miscellaneous jail cleaning and custodial supplies,
13 under CUE pricing subject to confirmation by County Council; and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
16 that the purchase order is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
19 of Ohio, that:

23 The award by the Board of Control of a purchase order with Zep Sales & Service for
24 miscellaneous jail cleaning and custodial supplies, under CUE pricing, in an amount not to
25 exceed \$100,000.00, is hereby confirmed and the County Executive is hereby authorized to
26 execute such purchase order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide jail cleaning and custodial supplies.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,
