7 **A Resolution authorizing the County Executive to execute an agreement with Oriana**
8 **House, Inc., for Adult Joint Drug Court programming, for the period of 1/1/13 through**
9 **12/31/13, in an amount not to exceed \$588,087.00, with two options to renew for an**
10 **additional one-year term, funded by the Fiscal Year 2012 Substance Abuse and Mental**
11 **Health Administration and Fiscal Year 2012 Bureau of Justice Assistance grants, for the**
12 **Executive's Department of Law, Insurance and Risk Management – Division of Public**
13 **Safety and declaring an emergency.**

15 WHEREAS, the United States Department of Health and Human Services has awarded a
16 Substance Abuse and Mental Health Administration ("SAMHSA") grant in the amount of
17 \$325,000.00, with no local cash match requirement, for the period 9/30/12 through 9/29/13, to
18 the County of Summit, for the operation of a Fiscal Year 2012 Joint Adult Drug Court program;
19 and

21 WHEREAS, this SAMHSA grant has a project period of 9/30/12 through 9/29/15, for a
22 total award of \$975,000.00, which is subject to performance review; and

23
24 WHEREAS, the United States Department of Justice has awarded a Bureau of Justice
25 Assistance ("BJA") grant in the amount of \$300,000.00, with no local cash match requirement,
26 for the period 10/1/12 through 9/30/15, to the County of Summit, for the operation of a Fiscal
27 Year 2012 Joint Adult Drug Court program; and

29 WHEREAS, this Council previously adopted Resolution No. 2013-013, which authorized
30 the County Executive to execute any documents necessary to accept the aforementioned grants
31 and appropriated grant funds; and

33 WHEREAS, it is necessary for this Council to authorize the Executive to execute an
34 agreement with Oriana House, Inc., for Adult Joint Drug Court programming for the period
35 1/1/13 through 12/31/13, in an amount not to exceed \$588,087.00, funded by the Fiscal Year
36 2012 SAMHSA and Fiscal Year 2012 BJA grants, with two options to renew for an additional
37 one-year term; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
40 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
41 execute the aforementioned renewal agreement.;

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
44 of Ohio, that:

48 The County Executive is hereby authorized to execute an agreement with Oriana House,
49 Inc., for Adult Joint Drug Court programming, for the period 1/1/13 through 12/31/13, in an
50 amount not to exceed \$588,087.00, funded by the Fiscal Year 2012 Substance Abuse and Mental
51 Health Administration ("SAMHSA") and Fiscal Year 2012 Bureau of Justice Assistance
52 ("BJA") grants, with two options to renew for an additional one-year term.
