7 **A Resolution authorizing the County Executive to execute a purchase order with Columbus**
8 **Equipment Company, subject to the approval of the Board of Control, for one Komatsu**
9 **CD60R-1A crawler carrier, 2010 model with 1,650 hours, as Best Practical Source, in an**
10 **amount not to exceed \$135,000.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
13 that it is necessary and in the best interest of the County of Summit to authorize the County
14 Executive to execute a purchase order with Columbus Equipment Company, subject to the
15 approval of the Board of Control, for one Komatsu CD60-R1A crawler carrier, 2010 model with
16 1,650 hours, as Best Practical Source, in an amount not to exceed \$135,000.00;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
19 of Ohio, that:

23 The County Executive is hereby authorized to execute a purchase order with Columbus
24 Equipment Company, subject to the approval of the Board of Control, for one Komatsu CD60R-
25 1A crawler carrier, 2010 model with 1,650 hours, as Best Practical Source, in an amount not to
26 exceed \$135,000.00.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide the crawler carrier.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,
