7 **A Resolution confirming an award by the Board of Control of a purchase order with BPI**  
8 **Information Systems for new servers for the migration to Windows project, approved by**

12 WHEREAS, the Board of Control, at its meeting held March 6, 2013, awarded a purchase  
13 order with BPI Information Systems for new servers for the migration to Windows project,  
14 approved by the IT Board 2/26/13, under State Term Pricing; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
17 that the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a purchase order with BPI Information Systems for  
25 new servers for the migration to Windows project, approved by the IT Board 2/26/13, under  
26 State Term Pricing, in an amount not to exceed \$27,600.00, is hereby confirmed and the County  
27 Executive is hereby authorized to execute such purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and  
32 welfare of the citizens of the County of Summit, and for the further reason to immediately  
33 provide for the Windows migration project in 2013.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take  
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
39 effect and be in force at the earliest time provided by law.

43 It is found and determined that all formal actions of this Council concerning and relating  
44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
45 deliberations of this Council and of any of its committees that resulted in such formal action,

47 121.22 of the Ohio Revised Code.


