7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Aero-Mark, Inc., for the 2013 Summit County Crack Sealing Program, in an amount not to**  
9 **exceed \$187,751.00, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held April 10, 2013, awarded a purchase  
12 contract with Aero-Mark, Inc., for the 2013 Summit County Crack Sealing Program, subject to  
13 confirmation by County Council; and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
16 that the purchase contract is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
19 of Ohio, that:

23 The award by the Board of Control of a purchase contract with Aero-Mark, Inc., for the  
24 2013 Summit County Crack Sealing Program, in an amount not to exceed \$187,751.00, is hereby  
25 confirmed and the County Executive is hereby authorized to execute such purchase contract.

29 This Resolution is hereby declared an emergency in the interest of the health, safety and  
30 welfare of the citizens of the County of Summit, and for the further reason to immediately  
31 provide for the crack sealing program in 2013.

33 SECTION 3

35 Provided this Resolution receives the affirmative vote of eight members, it shall take  
36 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
37 effect and be in force at the earliest time provided by law.

41 It is found and determined that all formal actions of this Council concerning and relating  
42 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
43 deliberations of this Council and of any of its committees that resulted in such formal action,

45 121.22 of the Ohio Revised Code.
