WHEREAS, the Ohio Department of Rehabilitation and Corrections ("ODRC") awarded \$7,000.00 in additional funding for Community Corrections Act Adult Probation salaries, for the state program year ending 6/30/13 ("SFY13"); and

WHEREAS, ODRC previously renewed an award to Summit County of a 407 program grant for SFY13 in the amount of \$1,239,107.00 to support alternative community correction programs for felony offenders in order to divert individuals from incarceration through programs managed by Oriana House, Inc., and the County of Summit Probation Department; and

WHEREAS, this additional ODRC award is to support salaries for program quality assurance testing; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to immediately accept the award of the aforementioned grant from ODRC, and to appropriate these grant funds;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
